If your company is funding the business trip, please state it in the letter. ➢ Invitation letter from the company in Vietnam stating your business purpose. (For business visa application) ➢ Flight Itinerary / Hotel Booking / Tour Itinerary (For tourist visa application) ➢ Visa Processing Fees: S\$240 (Single Entry), S\$420 (3 Months Multiple Entries), and service fees of S\$25 ➢ Processing Time: 6 – 10 business days ▪ India passport holders are not allowed to apply for urgent visa. ▪ For all other nationals visa fees, please drop us an email at enquiries@travelinc.com.sg and we will revert back to you in 2 business days.
