Form <b>must be completed online before printing</b> (complete <a href="#">form DS-160</a>)</li> <li>➢ Photocopied Employment pass / Work permit / PR NRIC</li> <li>➢ Company letter stating your designation, length of employment, current salary, travel dates. If your company is funding the business trip, please state it in the letter.</li> <li>➢ All of your old passports for the past ten years</li> </ul> </li> </ul>

Form <b>must be completed online before printing</b> (complete <a href="#">form DS-160</a>)</li> <li>➢ Photocopied Employment pass / Work permit / PR NRIC</li> <li>➢ Company letter stating your designation, length of employment, current salary, travel dates.</li> <li>➢ Photocopied bank statement transactions of last 3 months</li> <li>➢ All of your old passports for the past ten years</li> </ul> </li> </ul>			
Remarks	<ul style="list-style-type: none"> <li>▪ China passport holder need to submit 2 forms / 2 photos</li> <li>▪ To know which countries are under the Visa Waiver Program (VWP) please check out this website <a href="#">Visa Wavier Program</a>. However, please take note that the passport must be the correct type. Otherwise a visa is still required.</li> <li>▪ Effective 12 Jan 09, all VWP travellers must obtain an electronic travel authorisation prior to boarding a carrier to travel to USA. Log onto <a href="#">Electronic System for Travel Authorisation (ESTA)</a> and complete the online application at least 72hrs prior to travel. WEF 08Sep'10, a fee of US\$14 (S\$19) will be payable to the embassy by travellers when they obtain clearance through ESTA ahead of their journey.</li> <li>▪ For Singapore passport holders which are not sure if their passports are biometric, please check out the <a href="#">US visa waiver requirement update</a>.</li> </ul> <p><b>An interview is required for all visa applicants (age 14 &amp; above). If a visa is granted, 2 business days after the interview are needed to issue the visa. The applicant's passport will be held at the Embassy for these 2 days. No exception will be given.</b></p> <p><b>All visa interviews at the U.S. Embassy in Singapore are handled on an appointment basis only.</b></p>
