Business Visa (F-visa)	<ul style="list-style-type: none"> <li>▪ The requirements are as follows: <ul style="list-style-type: none"> <li>➢ Original Passport with at least 6 months validity and 2 blank visa pages</li> <li>➢ Complete visa application form (download <a href="#">application form</a>)</li> <li>➢ Photocopied Employment pass/Work permit/PR NRIC. If not, PR or Employment pass stamp must be reflected on the passport</li> <li>➢ Return air ticket / hotel booking</li> <li>➢ Original Official Notification of Issuance of Visa from the authorized department. This official note will need to be request by the China counterparts passenger is visiting. <a href="#">Sample of official notification</a></li> </ul> </li> </ul>			
Tourist Visa (L-visa)	<ul style="list-style-type: none"> <li>▪ The requirements are as follows: <ul style="list-style-type: none"> <li>➢ Original Passport with at least 6 months validity and 2 blank visa pages</li> <li>➢ Complete visa application form (download <a href="#">application form</a>)</li> <li>➢ Photocopied Employment pass/Work permit/PR NRIC. If not, PR or Employment pass stamp must be reflected on the passport</li> <li>➢ Return air ticket / hotel booking</li> <li>➢ Applicants going to visit family members should submit the certificate of family relationship</li> </ul> </li> </ul>			
Remarks	<ul style="list-style-type: none"> <li>▪ Visa is not required for Japan &amp; Brunei passports holders if they stay less than 15 days for visiting relatives or friends, doing business and tourism.</li> <li>▪ Bangladesh and Sri Lanka passport holders have to apply their visa personally. Please provide additional documents: last 3 months Bank Statement, Flight itinerary, Hotel voucher and contact person in China.</li> <li>▪ For Foreign Passport Holder born in China or once a China Citizen shall provide 1 of the documents: <ul style="list-style-type: none"> <li>- Photocopied of every Recent Chinese Visa and Front page of the passport.</li> <li>- Original and Photocopied of the front page of the cross out China Passport.</li> <li>- Photocopied of the Birth Certificate or Notarization.</li> <li>- Photocopied of the cross out Identity Card or Registered Residence Booklet.</li> </ul> </li> <li>▪ <b>Indonesia passport holder with Employment pass/Work permit/PR NRIC will need to apply visa in Jakarta if they had not been to China before.</b></li> <li>▪ <b>WEF 17May 10, French passport holders will need to apply visa in person.</b></li> </ul>
